A New Way to Work: Comprehensive Case Management and Employment Program (CCMEP)



Understanding CCMEP

When do you complete the program?

An individual may be considered to have completed the program when they have obtained employment, entered post-secondary education, enlisted in the military, or been awarded social security disability insurance and applied for services with Opportunities for Ohioans with Disabilities.

An individual may be required to leave the program if they repeatedly fail to meet commitments outlined in their plan.



Follow up services?

Individuals exiting the program will receive follow-up services for a minimum of 12 months.

What is CCMEP?

Comprehensive Case Management and Employment Program provides employment and training services for eligible, low income individuals based on a comprehensive assessment regarding their needs. Individuals are provided services that are outlined in their Individual opportunity plan based on their assessment. These services could range from supportive services to obtain schooling, job training, drug and alcohol counseling, or mental health services.

There are many services available with each plan being tailored to the individual participant.

Keys to Success?

CCMEP's success is based on the individual's active participation in the program and meeting with the case manager on a regular basis. CCMEP individuals are required to commit to participating in activities outlined in their plan for a minimum of 20 hours a week.

The case manager is required to meet with individuals at minimum every 30 days to review participation and progress.

Who is eligible to receive services through CCMEP?

Effective July 1, 2016 in Hancock County individuals age 16-24 served by TANF and other Youth Programs will be served through CCMEP.

The following individuals ages 16 to 24 <u>are required</u> to participate:

Low income in school and out of school youth considered to have a barrier to employment and registered for a youth program through WSOS. Individuals in the cash assistance program who are work required.

The following individual's age 16 to 24 may volunteer to participate:

Individuals in the cash assistance program who are not work required. Individuals receiving benefits or services through the prevention, retention, and contingency (PRC) program.
